1.0 Introduction

2.0 Sittings

During the period July-December 2011, the Committee held thirty six (36) sittings.

3. 0 Mode of operation

During the period of review, the Committee examined the following subjects that fall under its purview-

i. Assurances made by Ministers on the floor of the House in the fourth session; (see appendix 1)

ii. Petitions presented during the fourth session; and, (see appendix 2)

iii. Resolutions made by the House during the fourth session.

(See appendix 3)

The Committee compiled a schedule of assurances and submitted them to respective Ministries seeking the implementation status of the commitments. The Committee considered the responses from the Ministries against the undertakings made.

The Committee subsequently scheduled meetings with Ministers to follow-up on the implementation status of the assurances. However, some Ministries did not respond and that failure and appropriate sanctions, as necessary, will be subject of the Committee program in the coming year.

Further, the Committee undertook a field visit to a stalled ice making project in Faza Island, Lamu.

This visit was intended to achieve two main objectives-

- i. To verify/ascertain the information issued by the Minister against the prevailing situation on the ground and to ensure that the Minister honoured the undertaking and,
- ii. To ensure that the assurance was not merely given at the spur of the moment and that the House did not act in vain.

4.0 External Study Tour

The Committee was not able to undertake any study visit due to budgetary constraints. However, the Committee intends to undertake visits to Nigeria and Uganda, among others in February 2012 to exchange experiences on the exercise of oversight on the executive.

5.0 Activities of the Committee during the period:

- a) The Committee held meetings with the Ministers for industrialization, Finance and the office of the Attorney General to follow up on the assurance to reopen Pan African Paper Mills, Webuye. Details of these meetings have been discussed in detail herein (paragraph 8) including observations and recommendations because of the economic importance of the factory to the people of Webuye and the country at large;
- b) The Committee undertook a visit to Faza Island to ascertain the status of the Ice Plant arising from an assurance made by the Minister for Fisheries Development on 5th August, 2009. Further, the Committee held two meetings with the Ministers for Fisheries Development and Public Works on delays in the completion of the project. This project is discussed in detail under paragraph 9.

- c) The Committee held a number of meetings with the Deputy Prime Ministers for Local Government and Finance on the Economic Stimulus programmes (market component). A joint meeting between the Ministries of Local Government, Finance and Public Works had been scheduled but was not held due to non-availability of Ministers for Local Government and Public Works.
- d) The Committee scheduled a joint meeting with the Minister for Water and Irrigation and the Minister for Agriculture on the resolution of the House to establish small holder irrigation schemes in the 210 constituencies in the country. However, the Minister for Agriculture did not attend the meeting and no reason was given for the failure.
- e) The Committee held a meeting with the Minister for Education on the resolution of the House to amend the rules governing nomination of B.O.G members for public schools. The Committee will hold a follow up meeting with the Minister to know the outcome of the engagement between the Minister and the representatives of schools' sponsors and other stakeholders.
- f) The Committee noted that as a result of its follow up, the resolution of the House on training of Ministers and other constitutional office holders had been implemented through an Induction Seminar, National Leadership Retreat and a curriculum on Training and Capacity Building where one of the thematic areas is public finance and procurement.

- g) The Committee noted that action had been taken on the resolution of the House to increase funding for higher education. Further, the Committee noted that action was being taken on the resolution on the enhancement of funding to public primary and secondary schools. These measures included mobilization of resources for infrastructural development and provision of bursary funds to needy and bright students.
- h) The Committee noted that action had been taken on the report of the Committees on Equal Opportunity and Delegated Legislation on the appointment of the KMTC director by regularising the process
- i) The Committee scheduled a meeting with the Minister of State for Provincial Administration and Internal Security to discuss the reports of the Departmental Committee on Administration and National Security on the fact finding visit to Samburu East and Isiolo North and the report on the investigation on the activities of the Artur Brothers. However, the meeting did not take place as the Minister did not attend. A further meeting will be scheduled. On the report on the investigations of the Artur Brothers, the Committee wrote to the Director of Public Prosecutions on measures to implement the report. Initially the Director of Public Prosecutions wrote back informing the Committee that he had not received the report. Consequently, a report was submitted to the DPP for his action on the matter but by the time of compiling this report no communication/ or feedback on the matter had been received. The Committee recommends that the DPP moves expeditiously to implement the report.

- j) The Committee also considered the resolution of the House on measures to protect Cherangany Hills forest from adverse human activities and noted that action had been taken. Interventions by the Ministry include sensitization of the public and leaders on the need to protect the forest, setting up an inter- ministerial Committee to settle those Kenyans that have been removed from the gazetted forest, seeking support from other leaders to visit Marakwet County to sensitize the Community on the need to protect the forest and establishment of a task force to determine the genuine squatters.
- k) The Committee deliberated on the Resolution of the House to establish two water services boards in the North Rift and noted the report from the Ministry of Water and Irrigation indicating the ongoing reforms aimed at aligning the Water Act to the new Constitution. In this regard, a task force has been created to realign the Water Act, 2002, the sector policies and the sector institutions to the new constitution.
- 1) The Committee considered the report from the Ministry of Agriculture on the petition to the Government to give a grant of Kshs. 800 million to the Pyrethrum Board of Kenya and noted the measures taken by the Government towards revitalising the Pyrethrum industry. Additional information sought from the Ministry is being awaited on funds raised from the sale of assets and amount of money owed to farmers.

m) The Committee also considered the petition on the Mau Mau war veterans and noted that it had been referred to the Departmental Committee on Justice and Legal Affairs.

6.0 Challenges faced by the Committee in executing its mandate

- a. Non compliance by the ministries with the provisions of Standing Order no. 183 on the tabling of reports within 60 days after a Resolution has been adopted. This is because the Executive does not have an operational mechanism to communicate, especially the resolutions of the House to the respective Government agencies;
- b. Non compliance by the ministries with the provisions of Standing Order no. 210 (2) on the submission of responses to petitions presented within the stipulated time;
- c. Lack of mechanism to follow-up operationalisation of Bills passed; and
- d. Lack of reliable database and tracking system of Government undertakings/assurances; and
- e. Failure by Ministers to honour invitation to Committee meetings and to respond to the status of implementation of assurances and resolutions.

7.0 Recommendations

- i. Sensitize Ministers on their obligations on Resolutions adopted by the House, assurances made, petitions presented and Bills passed by the House;
- Revision of the Standing Orders to address the challenges experienced in paragraph 6 (a), (b) and (e) above;

- iii. Development of partnerships with other organizations to assist to track the status of implementation of passed Bills;
- iv. Review of the Committee's Strategic Plan and tracking system of matters under the purview of the Committee; and
- v. Creation of a specific and permanent Secretariat dealing with tracking of all the assurances, resolutions and all other matters that fall under the Committee's terms of reference.

8.0 REPORT ON THE RE-OPENING OF PAN AFRICAN PAPER MILLS

The question of Pan African Pa'per Mills, Webuye has been before the Committee on Implementation for the last two years following an assurance by the Assistant Minister for Industrialization on 28th May, 2009. The undertaking was made in response to a question by private notice filed by the Member for Webuye (Hon. Alfred Sambu) regarding the re-opening of the paper mill. The question read as follows:

"(a) Could the Minister table the findings and recommendations of the task force constituted by the Government to investigate the closing down of Pan African Paper Mills in Webuye?

(b) When will the employees who were in employment at the time of closure, and who were not compensated, receive their compensation?

(c) Could the Minister confirm that the factory will re-open on 1st June, 2009 as promised by the Government?"

In his reply, the Assistant Minister for Industrialization (Hon. Nderitu Muriithi) confirmed that the Government appointed a technical and financial evaluation

task force on 2nd April, 2009 to undertake an urgent evaluation of Pan African Paper Mills, East Africa Ltd to establish the viability of the company. The report by the task force noted that the company was technically and financially viable subject to the restructuring of debts owed by the firm. The Assistant Minister also informed the House that the concerns of all former employees of the company including those laid off by the receivers would be addressed when the discussions which were on-going at the time were concluded. He further confirmed that the factory was initially scheduled to re-open around 1st June, 2009, but due to unforeseen technicalities; the re-opening was rescheduled to take place later in the same month. He assured the House that the company would re-open at the end of June, 2009. The assurance was recorded as follows in the *Hansard:*

...."secondly, I could commit myself to re-opening the factory on 21st June,2009 but I know this process has certain issues that may force us not to re-open it on that date. I wish the Hon. Member could accept the last week of June as the firm target that we have given the teams that are working there, to deliver a working factory at Webuye."

However, when the factory failed to re-open as promised, the member for Webuye sought a ministerial statement on 4th August,2009 seeking a firm workplan indicating the exact date¹ of re-opening the factory. The matter was again raised in the House by the same member on 13th August, 2009, who enquired from the Chair on when the statement would be issued.

Eventually, the Minister for Industrialization issued a statement regarding the state of Pan African Paper Mills on 19th August, 2009.

In the statement, the Minister informed the House as follows:

- a) Pan African Paper Mills (PPM) was established in 1967 with majority shareholding of 54% by Opil Group of India whereas the Government and other investors like IFC were minority shareholders;
- b) The company accumulated huge debts over the years which it was unable to service culminating into its abrupt closure on 30th January,2009 due to power disconnection arising from non-payment of bills to KPLC;
- c) The management which was also the majority shareholder absconded to India in March, 2009 without the knowledge of the Government;
- d) The company's performance prior to the closure had deteriorated which was attributed to failing plants, inadequate wood supplies, high cost of fuel and stiff competition from imported cheap paper products;
- e) The above factors resulted in the formation of a task-force which was working with the management of PPM on the implementation of turn-
- f) There appeared to be something wrong with the management structure of the company and there could be a criminal element and it would be necessary to conduct forensic audit before re-opening the company;
- g) The task-force appointed by the Government was negotiating with lenders and key suppliers on the revival of the plant under a joint receivership as directed by the Cabinet;

- f) There appeared to be something wrong with the management structure of the company and there could be a criminal element and it would be necessary to conduct forensic audit before re-opening the company;
- g) The task-force appointed by the Government was negotiating with lenders and key suppliers on the revival of the plant under a joint receivership as directed by the Cabinet;

- h) The International Finance Corporation (IFC) and Proparco agreed to write off their loan amounting to Ksh. 3.3 billion reducing indebtedness to Ksh.
 5.2 billion;
- The Treasury had set aside Ksh. 500 million as part of the revival package for the plant; and,
- j) A Cabinet memo had been prepared seeking further direction on the matter and a response was being awaited.

The matter was subsequently referred to the Committee on Implementation by the House on 19th August, 2009 to investigate the circumstances surrounding the closure of Pan African Paper Mills and especially inquire into the factors against its re-opening as earlier promised by the Assistant Minister.

The committee held meetings with the Minister and Assistant Minister for Industrialization who were accompanied by officials from the Ministry. The committee also invited the Solicitor General, the Permanent Secretary, Treasury and the Permanent Secretary, Ministry of Forestry and Wildlife. The Ministers and officials provided invaluable information and their insight on the matter in question assisted the committee in understanding the history of Pan African Paper Mills, its operations and circumstances surrounding its closure.

Arising from the foregoing inquiry, the committee prepared a report which contained the following notes and observations.

a) The closure of Pan African Paper Mills has adversely affected the economy of the country and particularly that of Webuye town and its environs;

- b) The question of Pan African Paper Mills involves many parties which includes majority and minority shareholders, long-term and short-term lenders, suppliers and employees, which makes revival efforts very complex;
- c) The Government has demonstrated intention and further taken tangible measures aimed at the revival of the company; and,
- d) The Assistant Minister made a firm commitment to the House in good faith that PPM would be re-opened at the end of June, 2009 but Government efforts have been hampered by other parties with a stake in the plant.

After examining the above factors, the Committee recommended that the Government should continue and even enhance its efforts to ensure that the Pan African Paper Mills re-opened as soon as practically possible to safeguard the national interest. As mentioned earlier, this report was adopted by the House on 18th November, 2009.

In addition, the Committee undertook to follow-up the assurance made to the House to its logical conclusion as well as the implementation of the resolution on the matter.

8.1 Recent measures to revive the Pan African Paper Mills

The Ministry of Industrialization was assigned by the Government the task of reviving the factory. The Ministry constituted a task Force which prepared a cabinet Memorandum which was jointly signed by the Ministers for Industrialization, Finance, Forestry and Wildlife. The cabinet Memo was approved on 28th April, 2010 with the following directives-

- That the short term lenders proceed to sell their stocks on which their debt is secured, which process they noted to have already began;
- 2) That the Government negotiates with the long term lenders to place PPM under a protective receivership under which production could begin;
- 3) That in the event negotiations for a protective Receivership were not successful, the Government to consider working with the long term lenders to facilitate an outright sale of PPM.

The Ministry of Industrialization undertook the following measures to implement the cabinet Memo-

- Wrote to short term lenders to sell their assets which include manufactured paper, waste paper and other movable assets of PPM;
- 2) Through the task Force started negotiations with long term lenders on the purchase of PPM;
- 3) The State Law office commenced preparation of relevant documents for incorporation of Webuye Paper Mills Ltd. which could be used as a special purpose vehicle to purchase PPM.

The Committee was informed that the short term lenders failed to sell their assets while the long term lenders authorized the Government to run the mills to prevent wastage and deterioration of their assets. In addition, the Committee was informed that the negotiations for the sale of PPM were adversely affected by the absence of one of the long term lenders to reach an agreement on this issue, Deutsche Bank, making it difficult for lenders to reach an agreement on the matter.

8.2 Current status of Pan African Paper Mills

The Ministry has made considerable progress in preparation, re-opening and full operation of the PPM and trial runs undertaken have resulted in production of an estimated 5,000 tonnes of paper through the three machines lines that have been rehabilitated. The Ministry has been facilitating the paper mill by procuring all raw materials, all operational materials, some of the equipment and minor maintenance works. About 1024 workers are currently working at the plant and the number is expected to increase when the fourth machine is rehabilitated. The Ministry confirmed that so far, the Government has spent around Ksh. 1.6 billion in the revival of PPM.

The Ministry commenced negotiations with the short term lenders who were willing to sell their stake in PPM to the Government for a settlement of Ksh. 400 million. In turn, the Government would take over the receivership and lenders would withdraw cases filed against the Government. A settlement agreement to be executed by the Government and the lenders was prepared to put this into effect but it has not been executed.

The Ministry has identified the following challenges in the revival efforts-

- The absence of an operational account has frustrated the running of the plant;
- The lengthy procurement procedures under the public procurement and disposal Act hamper the operations;

- 3) Most suppliers are unwilling to deal with PPM on credit basis given that it is under receivership and the attendant uncertainty on its legal status;
- 4) Negotiations with short term lenders have not been concluded. The opinion of the State Law Office is that the settlement agreements should not be executed with the recommendation that the Government should proceed with negotiations with long term lenders to purchase PPM through Webuye paper Mills Ltd. This opinion is based on the need to comply with the cabinet decision of 28th April,2010;and
- 5) There are two cases instituted by some short term lenders which have not been determined.

The Committee undertook an inspection visit of the plant on 29th April, 2011 where it held a meeting with the District Commissioner, Bungoma East who reiterated the negative impact of the closure of the plant on the community and hence the need to pursue revival efforts. The Committee also met the task Force and witnessed logs being delivered from purchases made from the grant by the Government as well as manufactured paper with an estimated market value of Ksh. 210 million.

In view of these developments and given the current status of the plant, the Committee made the following observations-

1. The Government continues to demonstrate a commitment to the full revival of the PPM through the injection of funds and other actions especially through the task force;

- 2. It is inconceivable that a mill whose value is estimated at Ksh. 20 billion should be in-operational taking cognizance of the domino effect on the regional and national economy;
- 3. The negotiations have taken too long which is likely to impact negatively on the revival efforts especially taking into consideration the current position of the plant and the uncertainties regarding its legal status;

8.3 <u>Recommendations</u>

The Committee recommends that the Government institutes structured negotiations with the parties with a stake in the plant to ensure that the question of ownership is addressed and ensure that the plant is fully operational by 30th March, 2012. In particular, the Committee strongly recommends that the Cabinet Memo approved on 28th April, 2010 be fully implemented as follows:

- a) That the short term lenders proceed to sell their stocks on which their debt is secured, which process the Committee noted has already began;
- b) That the Government negotiates with the long term lenders to place Pan African Paper Mills, Webuye under protective receivership on the lines similar to Uchumi Model, under which production could begin;
- c) That in the event negotiations for a protective Receivership were not successful, the Government to consider working with the long term lenders to facilitate an outright sale of Pan African Paper Mills, Webuye to the proposed Webuye Paper Mills Ltd; and

d) The Attorney General should commence interpleader proceedings to secure the assets of the Company during the period of transition.

9.0 REPORT ON THE COMPLETION OF THE FAZA ICE PLANT, LAMU

The issue of Faza ice plant in Lamu emanated from an ordinary question by Hon. Shakila Abdalla on 5th August 2009. The question read as follows:

(a) Could the Minister indicate what became of the cold house or ice plantproject in Faza (Lamu) which was to commence operations in December,2008 and clarify the stage of the tendering process?

(b) What plans does the Minister have to provide an alternative source of power for the cold house, considering that the generator at the plant cannot provide sufficient power?

In response, the Minister for Fisheries Development stated as follows-

"The retendering for the mechanical bit was done earlier this year. We have factored in to ensure that before the close of this financial year, this component which the earlier contractor had supplied sub-standard equipment is going to be finished. Actually, it is going to be finished before December......That is why I am saying that procuring new equipment takes a bit of time. I have been reassured that after this retendering, within the next six months, it will be completed. The money is already there."

It was with the above assurance that the Committee undertook an inspection visit to Faza Island in Lamu on 12th August, 2011 to verify whether the project had been completed as promised to the House by the Minister.

9.1 Inspection visit to Faza Ice Plant, Lamu

The Committee visited the Faza Ice Plant on 12th August, 2011 and held meetings with the Acting District Commissioner, Lamu East, Chairman of the fishing community and officials from the Ministry of Fisheries Development led by the Director of Fisheries.

The Committee was informed as follows-

- 1. The designs for the proposed project were prepared in 2007 by the Ministry of Public Works and it was to incorporate a fish/ice landing area with a sink and worktop, a fish cold room and a refrigeration plant room, an ice flake plant and ice flake storage room, two offices, a waiting lobby and water closet/shower rooms.
- 2. The project was advertised on 8th May, 2007 and after completion of the tender evaluation and adjudication, the works were awarded as follows
 - a. Civil Works- Ms Banu Asad Contractors for a sum of Ksh. 6,149,447.70
 - b. Electrical works- Ms Wassy Electrical Services for a sum of 2,528,216.30
 - c. Mechanical works- Ms Saary General Suppliers for a sum of Ksh. 9,108,598.00 bringing the total to Ksh. 17,786,262.00;
- 3. The project was to be built at Kizingitini Island but was later moved to Faza Island due to a land dispute over the proposed site;
- 4. The electrical works were certified complete and the civil works were 85% complete while the cold room installations including ice flake and ice block making machines are yet to be installed;

- 5. The mechanical sub-contractor, Ms Saary General Suppliers supplied ice flake and ice block making equipment that were rejected by the Provincial Electrical/Mechanical Engineer late 2008 and the contractor ordered to remove them from site. The contractor requested for a 70% price increase in order for them to supply the ice plant as specified which was not granted;
- 6. The District Fisheries Officer, Lamu was advised in March 2010 by the Ministry of Public Works that the outstanding builders and mechanical works would require Ksh. 14.5 million to be completed. The works were retendered on 20th January,2011 and upon tender opening and evaluation, it was recommended that the works be awarded to Ms Southern Engineering Co. Ltd at a tender price of Ksh. 29,116,180;
- 7. The Permanent Secretary, Fisheries Development later suspended any further expenditure until the Public Accounts Committee visits the project site and the two bills of quantities provided by the Ministry of Public Works is clarified.

Arising from the visit, the Committee made the following notes and observations:-

- Electrical works were not 100% complete as indicated since the ice plant machine had not been installed;
- The walls of the building had not been painted, the roof was leaking and some doors were missing. In addition, the generator room was not properly secured;
- 3) The stalling of the project has negatively affected the community residing in Faza and adjoining areas which largely depend on fishing activities and who are keen to see the project completed as a priority;

- 4) Stalling of the project has created disenchantment in the community;
- 5) The biggest loss is lack of benefit to the community and particularly the opportunity cost;
- 6) The Minister misled the House by categorically stating that retendering had been done in 2009 as it was undertaken much later on 20th January, 2011.

9.2 Ministry of Fisheries Development Intervention

Consequent to the Committee enquiry and the disparities in the amounts needed to complete the project from the Ministry of Public Works, the Ministry of Fisheries Development constituted a task force to visit the project site and to submit a report and recommendations. The task force recommended that the project be mutually wound up on 'AS IS' basis and further examined the various options available to operationalise the project. It was recommended that the project be scaled down.

The Committee held a further meeting with the Minister for Fisheries Development who promised that the Ministry was going to retender the remaining works. The Minister further assured the Committee that by May 2012, the project will be completed.

9.3 <u>Recommendation</u>

The Committee recommends that the Ministry of Fisheries Development takes immediate measures to ensure that the project is completed and commissioned by May 2012 given the expected benefit and enormous opportunity cost to the

community. These measures include scaling down the scope of works as recommended by the Ministerial task force as follows:

- a) Supply and installation of 2ton/24hr ice block machine which would cost approximately Kshs. 3 million;
- b) Supply and installation of 3Kw refrigeration equipment for the ice cold room;
- c) Installation of the fish cold room of dimensions 8.0x3.8x3.5
 m high;
- d) Installation of the ice cold room of dimensions 2.3 x4.4x3.5
 m high;
- e) Development of a 10 meter deep water well;
- f) Provision of high level water tanks and associated water booster pumps;
- g) Completion of internal plumbing works;
- h) Completion of internal drainage works and connection sewer;
- Associated electro-mechanical works associated with the above installations;
- j) Completion of civil works i.e glazing, doors, shutters, painting and gutters; and
- k) Supervision of the works to completion.

10.0 Conclusion

During the period under review, the Committee attained the following achievements-

- Ministers became conscious that the assurances made in the House as well as resolutions adopted were being followed up by Parliament which created an impetus for implementation; Undertakings on Pan African Paper Mills and the Faza Ice plant project are cases in point where Committee enquiry was used by Ministers as a basis of action;
- 2. The visit by the Committee to Webuye in early 2011 and to Faza Island in August 2011, created a linkage between the institution of Parliament and the people it represents; The Committee observed that the visits were an assurance to the people that their concerns were being addressed; It was also a very strong signal that arbitrariness and inaction especially in the far flung areas of the country by Government agencies will be exposed and officers made to account;
- 3. The Committee also provided a forum for Ministers to explain their policies and actions to specific questions and to receive feedback on projects in various constituencies. In essence, the Committee created a linkage between the executive and legislature which has hitherto been missing especially in following up on undertakings made by Ministers and resolutions adopted by the House.

From the foregoing, it is clear that the reintroduction of the Committee after the review of the Standing Orders in December, 2008 has enhanced the oversight role of Parliament through the creation of a specialised Committee on Implementation. The Committee has made major strides in furtherance of its mandate. However, there are several challenges as mentioned earlier which need to be addressed particularly in following up on Treasury Memoranda on the reports of the Public Accounts and Public Investments Committees. The recommendations made in this report (paragraph 7) will significantly ameliorate these challenges.

Once again, this is to extend appreciation to members of the Committee for their dedication and commitment in furtherance of their mandate.

MIN.NO. 200/2011 : PRELIMINARIES

The proceedings were opened with a word of prayer.

The Chairperson explained that the purpose of the visit by the Committee was to establish the status of implementation of an assurance made in the House by the Minister for Industrialization and a subsequent resolution on the re-opening of the Pan African Paper Mills, Webuye.

MIN.NO. 201/2011 : CONSIDERATION OF THE STATUS OF REOPENING OF PAN AFRICAN PAPER MILLS, WEBUYE

The Committee was informed as follows:

- The Factory was put under receivership in early 2009 by the short term lenders comprising of KCB ,Ecobank, Bank of Baroda and Barclays bank. At the time of closure, the company had a total liability of kshs. 8 billion. A total of Ksh. 1.3 billion was owed to the short term lenders while the remainder was owed to the long term lenders;
- The reopening of the factory was not possible due to the receivership status and despite the Government injecting Kshs. I billion, the company is not able to operate normally;
- The Government appointed a task force to oversee the day to day running of the affairs of the factory and to secure the equipment; It was mandated to negotiate with the lenders on repayment of the debts and that an agreement has been drafted with the short-term lenders which is awaiting signature;
- The short-term lenders did not have an objection in the company continuing to operate even though the Government evicted the Receiver Manager. The Receiver Manager continues to draw proceeds from the factory;
- Due to bureaucracy in procurement process, the mill was experiencing delays in acquiring raw materials;
- The paper mill is viable and when one machine is running fully, 600 people are employed instantly;

- The Government at some point resolved to register another company, Webuye paper Mills to be used as a vehicle to trade. However, the Permanent Secretary (Industrialization) signed the approval but the Permanent Secretary (Treasury) failed to sign. No reason was given for the failure by the Treasury to approve the arrangement; Selling the plant by the Government is not an option as it has no legal right over the plant;
- An amicable settlement with the lenders will allow the plant to operate and enable it to access sales held by paper converters and sell ready stock estimated at Kshs. 210 million.

MIN.NO. 202/2011 : TOUR OF THE PLANT

The Committee toured the factory and witnessed logs being delivered from purchases made from the grant by the Government. The raw materials received totaled to 1000 cubic meters of wood per day;

The Committee was also informed that the plant has capacity to produce 9 mega watts of electricity and that it has a monthly turn-over of Ksh. 450 million.

The Chairperson thanked the taskforce for facilitating the visit and providing information which will be useful in discharging its mandate on the matter

The Committee issued a press statement briefing the media on the mandate of the committee, the purpose of the visit and general observations on the plant.

- The Committee sought to know what the Ministry was doing in order to get off the hook from the Long Term Lenders (LTLs). The Ministry informed the Committee that they intend to engage the LTLs immediately the Settlement Agreement is signed with the Short Term Lenders;
- The Committee further heard that there is an agreement between the Ministry and the short term lenders for the Ministry to settle Kshs. 400million for the receivership to be handed over to the Ministry. The Ministry is expected to come up with the way forward in regard to the appointment of the receiver Manager;
- The Committee was informed that the Ministry will by end of September this year, finalize the discussions with the short term lenders;
- The Committee learnt that the Ministry was due on 7th June, 2011 to sign a Settlement agreement drafted by both teams from the Ministry and the short term lenders in order to fast track the full operationalization of the factory;
- The Committee learnt that the Ministry is not able to sell the paper to converters because the cheque is drawn to the short term lenders and therefore had opted to have a strategic registration of a new 'vehicle' for use to trade;

- The Committee further sought to know whether there was any firm commitment by the Ministry to revive the plant to protect the interests of Kenyans. The Committee was informed that the Ministry has revived three machines;

- The Committee wanted to know whether the Ministry was considering pursuing the issue of 'debt purchasing' in order to help settle the debt owed to the short term lenders;
- The Committee sought to know the principal amount owed to the short term lenders and how much has the Government spent so far, in reviving Webuye Pan African Paper Mill;
- The Committee directed the Ministry of Industrialization to present the Minutes that culminated into the drafting of the agreement between the Ministry and the short term lenders;

The proceedings commenced with a word of prayer. The Chair welcomed the officials of the Ministry of Industrialization, Finance and the Attorney General's office to the meeting. The Chair explained the purpose of the meeting, namely, following up the assurance made in the House on the reopening of Pan African Paper Mills, Webuye.

MIN.NO. 231/2011 : MEETING WITH THE MINISTRIES OF INDUSTRIALIZATION AND FINANCE AND THE ATTORNEY GENERAL

The Assistant Minister for Industrialization informed the Committee as follows-

- a) The Pan African Paper Mill was not operational due to unwillingness by the Short Term Lenders (STLs) in signing of the Settlement Agreement and their shifting of goal posts;
- b) The STLs demanded that the Government assigns tax receivables i.e. the government undertakes VAT refunds to the STLs but the government is hesitant in applying the model since it may be in breach of laws relating to revenue;

MIN.NO.232 /2011: WITHDRAWAL OF THE MEDIA

On the request of the Minister, the Committee agreed that the media should be excluded from the remainder of the sitting pursuant to standing order 180.

The Assistant Minister further informed the Committee as follows-

- c) The Cabinet had offered two options, which were to either persuade the STLs to an agreement or a take-over based on the "Uchumi" model;
- d) The government is also considering buying off the equipment of the Pan African Paper Mills and create a new 'vehicle', Webuye Paper Mills and has already drafted Memorandum of Understanding and Articles of Association;
- e) The Government has so far invested a total of Kshs. 1 billion with the bulk of the money spent in paying salaries to the workers on the ground and to KPLC;
- f) The government has further set aside a sum of Kshs.800 Million;
- g) Two of the STLs are also Long Term Lenders (LTLs); and

h) The lenders are taking advantage of the government commitment to reopen the plant.

The Committee directed that the Ministry should present a report after every 45 days indicating progress made towards reopening the plant.

MIN.NO. 313/2011 : MEETING WITH THE MINISTER FOR FISHERIES DEVELOPMENT ON FAZA ICE PLANT IN LAMU

The Committee heard the following:

- The government had initially intended to build the ice plant at the Fisheries Department Land in Kizingitini Island. The Land was apparently in dispute so the Ministry had to relocate to Faza Ice Island;
- 2) A total of Kshs. 16.6 million was allocated to the project in the FY 2006/07;
- 3) In FY 2007/08 no money was allocated and by that time the Electrical works and civil work had been completed. The contract for the mechanical works was terminated due to the contractor (M/s Saary) supplying a sub-standard equipment;
- 4) In FY 2008/09, no funds were allocated since Kshs. 8.2 million was still held at the Lamu District Treasury;
- 5) In 2009/10 the Ministry of Public works re-evaluated the remaining works and gave an estimate of Kshs. 14.5 million on the remaining works including building works (Kshhs.1.0 million), pending bill (Kshs. 1.2 million) and Mechanical works (Kshs. 12.3). The District Fisheries queried the figures and requested for funds to re-advertise the works. The funds were not released as the revised estimates were approved towards the end of the May, 2010 and it was not possible to utilize the funds before closure of the Financial Year;
- 6) In FY 2010/11, an A.I.E of Kshs. 4.6 million was issued to the District Fisheries Officer in Lamu in addition to the Kshs. 8.2 Million held at the District Treasury, Lamu. However the Kshs 4.6 million was reallocated to a landing beach project in Moa, Witu Division within the same Lamu District;
- 7) An advertisement on the mechanical was done in January, 2011 and the tenders were adjudicated on April, 2011 with the lowest as Kshs.11.0 million and highest as Kshs. 58 million. The District Tender Committee recommended the bidders for Kshs. 29.5 million which was far above Public Works estimate of Kshs.14.5 million; and

- 8) Due to the disparities in the figures, the Ministry has constituted a team of officers to visit the project site and to submit a report and recommendations by 30th September, 2011 whose terms of reference are:
 - To evaluate and quantify the remaining works;
 - Evaluate the viability of the project on the basis of cost effectiveness and efficiency in the production of ice vis-viz from buying from the local market;
 - The project ownership and sustainability;
 - Examine the options available to make the project useful to the community.

The Committee resolved to hold a joint meeting with the Ministry of Fisheries Development together with the Ministry of Public Works on 4th October, 2011 to deliberate on the disparities in the cost of the project.

The proceedings commenced with a word of prayer and the Chair welcomed the Minister and other officials from the Ministries Fisheries Development together Ministry of Public Works present to the Meeting.

MIN.NO. 334/2011 : MEETING WITH THE MINISTRY FOR FISHEIRES DEVELOPMENT AND THE MINISTRY OF PUBLIC WORKS

The Chair invited the Minister for Fisheries to give an overview of the activities the Ministry has undertaken in a bid to complete Faza Ice Plant.

Scope of works

The Minister started by giving a brief on the intended architectural design of Faza ice Plant which comprised of the following:

- Fish/Ice landing area with a sink top and worktop;
- Fish cold room and an adjoining refrigeration;
- Ice flake plant;
- Ice block plant rooms;
- Ice flake storage room and adjoining refrigeration plant room;
- Two (2) offices;
- Waiting lobby; and
- Water closet/shower rooms

Initial tender awards

The project was advertised and the tender was awarded as follows:

- The tender for civil works was awarded to M/s Banu Contractors for a tender sum amount of Kshs. 6,149,447.
- The electrical works tender was awarded to M/s Waasy Electrical Services for tender sum of Kshs. 2, 528, 216.30.
- Mechanical works was awarded to M/s Saary General suppliers for a tender sum of Kshs. 9, 108, 598

The project was to be initially built in Ministry of Fisheries land in Kizingitini but due to land dispute the project was transferred to Faza Island.

Task force findings

Following the meeting with the Committee the Ministry constituted a task force to visit the project and submit a report by 30th September, 2011. The task force was mandated to:

Evaluate and quantify the remaining works;

- Evaluate the viability of the project on the basis of cost effectiveness and efficiency in production of ice vis-à-vis buying from the local market;
- Establish project ownership and sustainability; and
- Examine the options available to make the project useful to the community.

Upon visiting the site, the task force revealed that the civil works were 85% complete contrary to the earlier claim of 95% level of completion. The Committee sought to find out from the Minister if a full payment was made to the contractor despite of him doing 85% of the works. The task force upon evaluation found out that in order for the project to be completed with the initial specifications, it would require Kshs. 40.5 million an amount that cannot be realized this financial year or even through the supplementary estimates.

Further, the task force found out that the electrical sub – contract works had been certified as complete by the Public works officer in Lamu. However, the cold room installations including the ice flake and ice block making machines have not yet been installed.

The Committee was informed that there were a number of issues in regard with the various contractors which included:

- The Civil works contractor had made a claim of Kshs. 1.2 Million on account of additional works executed for land reclamation. On perusal of project file in Lamu, it was noted that there was a shortfall in funding of Kshs. 729,067 for the civil works.
- Mechanical sub contractor supplied ice flake and block making equipment that were rejected by the Provincial Electrical/ mechanical engineer. The contractor was ordered to get the machine out of the site. The contractor requested a price increase of 70% in order for them to supply to supply the ice plant as specified. The request was rejected and therefore the contractor abandoned the site.
- In March 2010.the District Fisheries Officer was advised by the Public works officers that the remaining civil and mechanical works would require a total of Kshs.14.5 million to be completed. The Committee further directed that the names of the officers who misled the Ministry be forwarded to the Committee.
- The remaining works were retendered on 20th January, 2011 and the tender was awarded to M/s Southern Engineering Co. Ltd at a tender sum of Kshs. 29, 116,180

- On 25th May, 2011, the Ministry of Public Works presented an estimate of Kshs. 56, 899, 869.60 which was disregarded because it was submitted after opening and evaluation of the bids.
- Due to the disparities in the estimation on cost of the project i.e Kshs.
 14.5 Million and Kshs. 56.9 million, further expenditure on the project was suspended until a inquiry by the Public Accounts Committee

The task force examined **4 options** that were available in order to complete the works that were remaining. In light of the budgetary constraint and since most of the funds allocated to the Ministry had been committed and that it would be impossible to ask for more funds from treasury. The task force settled for option 3 which requires scaling down works to Kshs. 13.7 million. This option will be designed in such a way that there will be room for future improvement by the County Government.

The Ministry will therefore require a further Kshs. 1 Million to be raised to top up to the Kshs. 12.8 million lying at the District treasury.

Option 3 was recommended and its scope was as follows:

- Supply and installation of 2ton/24hr ice block machine which would cost approximately Kshs. 3 million
- Supply and installation of 3Kw refrigeration equipment for the ice cold room
- Installation of the fish cold room of dimensions 8.0x3.8x3.5 m high
- Installation of the ice cold room of dimensions 2.3 x4.4x3.5 m high
- Development of a 10meters deep water well
- Provision high level water tank and associated water booster pumps
- Completion of internal plumbing works
- Completion of internal drainage works and connection sewer
- Associated electro-mechanical works associated with the above installations
- Completion of civil works i.e glazing, doors, shutters, painting, gutters
- Supervision

The Task force has since recommended that the contract at hand be wound up on 'AS IS' basis. Further the project should be concluded and final Accounts prepared.

The Committee cautioned the Ministry of the legal tussles that may arise if the contract was wound up. The Ministry informed the Committee that no contractor has raised any certificate and therefore there will be no claim for payment.

The Minister acknowledged the need for consultation between the client and the contractor in order to avoid some mistakes that would have been otherwise avoided.

The Minister informed the Committee that lack of specification of the model of the ice block machine led to the bidders bidding for different figures which led to disparities in the estimates.

Having noted the failures made from the beginning, the Committee acknowledged the importance of the Monitoring and evaluation all the projects.

The Ministry was directed to present a **progress report every 2 months** to the Committee.

The Minister emphasized his commitment to the conclusion of the Faza Ice plant. The Ministry gave the Committee an undertaking that by 2nd week of May 2012 the project will be ready to be commissioned.

MIN.NO.348/2011: MEETING WITH THE MINISTRIES OF INDUSTRIALIZATION AND FINANCE ON THE REVIVAL OF PAN AFRICAN PAPER MILLS, WEBUYE

The Chairperson briefly explained the purpose of the meeting and further emphasized the need to bring the matter to closure since it was of national interest.

The Committee enquired on the way forward in the revival of Pan African Paper Mills (PAPML).

The Assistant Minister for Industrialization highlighted the contents of the letter from the Ministry of Industrialization to the Committee dated 28th September, 2011 which identified various efforts that have been made towards the revival of the mills.

The Assistant Minister reiterated that the delay in finalizing the negotiations between the Government and the lenders has been occasioned by the fact that PAPML was a private company with the Government being a minority shareholder.

The Committee was informed that an Inter ministerial meeting was convened at the Prime Minister's office chaired by the acting Minister for Industrialization.

The meeting reviewed options for the way forward to revive PAPML. The meeting adopted the following options as a way forward:-

- a. The Government would proceed to pay Kshs. 400 Million to STLs and secure a commitment letter with respect to tax receivables from KRA;
- b. The Ministry of Industrialization to issue a formal notice to the STLs to attend a meeting to discuss the agreement on settlement of their claim;
- c. Treasury to sign the Articles of Association to finalize the registration of Webuye. The registered company will be maintained in abeyance as a possible alternative measure should option 1 fail; and
- d. The Ministry of Industrialization to engage legal experts to advise and negotiate on behalf of Government.

1

The Committee was informed that the letter with respect to tax receivables was drafted by the STLs but KRA disagreed with the content.

The Ministry of Industrialization also expressed fears of the lenders making further claims once the STLs are paid off.

The Committee noted that the mandate of the Committee was the revival of PAPML and the timeframe and not the modalities of revival.

The Investment Secretary reaffirmed the Government commitment in the revival of PAPML.

The Committee observed from the discussions that the Ministries of Industrialization and Finance were not in agreement on the modalities and mechanisms of the revival of PAPML.

The Committee therefore resolved to hold a meeting with the Ministry of Industrialization on Tuesday, 18th October, 2011. A subsequent meeting will be held with the Ministry of Finance.

- Keno/Kobil has a case pending in Court asking that the company be wound up and that there is an indicative figure to be paid to Long Tern Lenders;
- A legal option must be found to deal with the majority share holder once the lenders have been paid off;
- There are 2 types of stocks at PAPML namely spare parts & receivables which have already been documented. The other stock belonging to the Government is paper that has been produced;
- The STLs had been directed to secure their floating assets including the paper that was there before the Government moved in to revive PAPML;
- The STLs were demanding that the Government assigns tax receivables;
- The Ministry of Industrialization has managed to open an account with Central Bank where all the proceeds from sale of paper is being deposited; A meeting was held four weeks ago between the Ministry and customers to address the problem of tax payments to KRA;
- The machines at the PAPML are being serviced regularly to avoid corrosion;
- Currently machines 1,3, and 4 are in operation out of the 4 machines at the factory;
- By 10th November, 2011 the factory will resume operations using the 3 machines;
- The Permanent Secretary, Ministry of Industrialization is following up the issue of tax refund with KRA;
- The easiest option to revive PAPML is to allow the lenders to sell and pay off the STLs;

- A meeting by the cabinet on 27th April, 2010 approved a memo jointly submitted by the Deputy Prime Minister and Minister for Finance, the Minister for Industrialization and the Minister for Forestry and Wildlife;
- A meeting convened at the Prime Minister's office chaired by the acting Minister for Industrialization agreed that the Government proceed to pay Kshs. 400 million to the STLs and secure a commitment letter with respect to the tax receivables from Kenya Revenue Authority;
- The decision of the Cabinet is in variance with the minutes of the meeting held at the PM's office;
- The minutes of the meeting convened at the Prime Minister's office were not signed by the participants and that the Minister of Industrialization has disowned the minutes of the meeting;
- The hesitation in paying off the STLs is due to the unsigned minutes;
- The Ministry requires approximately Ksh. 2.5-3 billion to remove all encumberances related to reopening of PAPM; and
- The paper at the factory at the moment is worth Ksh. 210 million and that paper worth Ksh. 82 million was sold last week alone.

The Committee reiterated that the mandate of the Committee is not on the modalities of reviving the PAPML but to ensure that the factory is back to operation;

The Committee enquired on whether there are any conflicting interests either within or without that are impeding the process of revival;

The Committee directed that the list of names of the unsecured creditors be provided;

The Committee informed the Minister that the Committee will proceed to compile its report on the matter.


