## PREFACE

Mr. Speaker Sir,

The Constitutional Implementation Oversight Committee is established under Section 4 of the Sixth Schedule to the Constitution with the mandate of overseeing the implementation of the Constitution. The Constitution requires that the Committee shall:

- (a) *receive regular reports from the Commission on the Implementation of the Constitution on the implementation of the Constitution including reports concerning –*
  - (i) *the preparation of the legislation required by the Constitution and any challenges in that regard;*
  - (ii) *the process of establishing the new commissions;*
  - (iii) *the process of establishing the infrastructure necessary for proper operation of each county including progress on locating offices and assemblies and establishment and transfers of staff;*
  - (iv) *the devolution of powers and functions to the counties under the legislation contemplated in section 15 of the Sixth Schedule to the Constitution; and*
  - (v) *any other impediments to the process of implementing this Constitution;*
- (b) *coordinate with the Attorney General, the Commission on the Implementation of the Constitution and relevant parliamentary committees to ensure the timely introduction and passage of the legislation required by the Constitution; and*
- (c) *take appropriate actions on the reports including addressing any problems in the implementation of the Constitution.*

**Mr. Speaker Sir,**

This Parliament with the help of the Constitutional Implementation Oversight Committee in coordination with relevant Departmental Committees has vetted recommended and the House approved appointments to all the Commissions named above save for the National Land Commission whose names were forwarded to the President and still pending appointment and Teachers Service Commission whose names were rejected by the House due to lack of merit and regional balance.

In regard to the Public Service Commission, interviews for appointment to the Commission were conducted and names of the successful candidates forwarded to this House. The Departmental Committee on Administration and National Security moved with speed to vet the respective persons and tabled its report on January 08, 2013 for approval.

**Mr. Speaker Sir,**

In making these appointments, the Committees and Parliament tried as much as possible to keep to the spirit of the Constitution with regard to gender, regional balance, disabilities and marginalized communities as envisaged in Article 27 of the Constitution. This report provides the House with the opportunity to review and scrutinize the appointments made to various Commissions/ Independent Offices/Authorities/ Boards to be able to determine whether the appointments have taken into account the national values mentioned in Article 10 of the Constitution and whether they reflect the regional, ethnic and other diversities of the people of Kenya as provided for under Article 250 (4) of the Constitution.

**Mr. Speaker Sir,**

The new Constitution of Kenya was promulgated on August 27, 2010. It is a self driven Constitution in terms of establishment of required legislations with set timelines. As a Committee and Parliament we have worked tirelessly to keep to the timelines as set in the Fifth Schedule. To spearhead implementation of this Constitution several Commissions/ Independent Offices/Authorities/Boards have been established to fast track reforms in various sectors as required by the Constitution. The established Commissions include: -

- i. the Commission for the Implementation of the Constitution;
- ii. the Kenya National Commission on Human Rights;
- iii. the National Gender and Equality Commission;
- iv. the Commission on Administrative Justice;
- v. the National Land Commission;
- vi. the Independent Electoral and Boundaries Commission;
- vii. the Parliamentary Service Commission;
- viii. the Judicial Service Commission;
- ix. the Commission on Revenue Allocation;
- x. the Public Service Commission;
- xi. the Salaries and Remuneration Commission;
- xii. the Teachers Service Commission;
- xiii. the National Police Service Commission;
- xiv. the Ethics and Anti – Corruption Commission;

Suffice to mention that despite the delay by the two Principals in appointing the National Police Service Commission, on appointment the Commission moved with speed to have the posts of the Inspector General and his two Deputies advertised interviews conducted and the Inspector General vetted and approved by this House and, consequently appointed by the President. The two Deputies for Regular and Administration Police are yet to be appointed in accordance with Article 27 (8) of the Constitution.

**Mr. Speaker Sir,**

The term of the current three foreign Judges serving on the Judges and Magistrates Vetting Board namely Chief Justice Georgina (Ghana), Wood Justice Frederick Chomba (Zambia) and Justice Albie Sachs (South Africa) will expire on February 28<sup>th</sup> 2013. His Excellency the President in consultation with the Right Hon. Prime Minister nominated Hon. Justice (Rtd) Barnabas Albert Samatta (Tanzania), Hon. Lady Justice A.E.M. Mpagi-Mahigeine (Uganda) and Hon. Justice Joseph Asoka Nihal De Silva (Sri Lanka). The names and the accompanying curriculum vitae were on the 17<sup>th</sup> of December 2012 forwarded to the Departmental Committee on Justice and Constitutional Affairs for consideration prior to approval by the House. The Committee recommended to the House to defer the consideration of the names until the expiry of the term of the current non-citizen members of the Board on February 28<sup>th</sup> 2013.

### **General Committee Observations**

- (i) On many occasions prior to the publication of the legislation, the Constitutional Implementation Oversight Committee, made concerted efforts to impress upon the Executive on the need to publish the Bills in good time in order to allow Parliament sufficient time to consider the Bills both in Departmental Committees and in Plenary.
- (ii) Despite these efforts, in the end, most of the Bills were published less than a week or a month before the deadline of enactment of the Acts as set out in the Fifth Schedule. The table below shows a list of these bills.

(iii) Owing to the late publication of these crucial Bills, the publication period in respect of the Bills had to be reduced while the time for consideration of the Bills by the Departmental Committees was reduced to the bare minimum.

(iv) The late publication of the Bills did not deter Parliament in its resolve to ensure that all the Bills were enacted by set deadlines in the Fifth Schedule. Parliament prioritized the consideration of Bills relating to implementation of the Constitution above all other business before the House and made extraneous arrangements including holding of additional sittings on non-sitting days and the extension of the sitting hours, sometimes late into the night.

(v) A number of queries regarding the conformity of the published Acts to the resolutions of the House were raised in various fora, including Parliament. Although these concerns were promptly addressed by the Office of the Attorney-General, it is clear that had the Bills been received by Parliament in good time, the processing of the Bills for publication would have been much smoother and devoid of inaccuracies.

(vi) Further to that, various stakeholders petitioned Parliament on various fundamental aspects of the Bills arguing that if the Bills were passed in the form in which they had been published, they would contravene the letter and spirit of the

Constitution. This necessitated the request for an extension of time in terms of Article 261(2) of the Constitution. Although the Bills were eventually enacted into law, the Committee observes that early submission of the Bills to Parliament would have obviated the need for the extension of time for consideration of the Bills.

- (vii) Despite the challenges encountered by Parliament owing to the late publication of the legislation that required to be enacted within one year of the Constitution, legislation that required to be enacted within the first eighteen months of the promulgation of the Constitution was similarly published very late.
- (viii) Of particular concern to the Committee, is the legislation relating to land. This legislation sought to operationalize Chapter Five of the Constitution on Land and Environment by overhauling the prevailing land law regime so as to bring it into conformity with the new Constitution. The National Land Commission Bill, 2012 and the Land Registration Bill, 2012 were published on 10th February, 2012 while the Land Bill, 2012 was published on 13th February, 2012. This was despite the fact that these Bills required to be enacted on or before 27th February, 2012.
- (ix) The Committee further observes that the late publication of the Bills did not take into account all the processes relating to the enactment of legislation including the possibility of a Return of a Bill on a Presidential Memorandum. Despite this very late date of publication, the House made all efforts and passed these Bills before the due date.
- (x) However, previous experience has demonstrated that where all the Bills required to be enacted by a set constitutional deadline are published at the same time, the quality of legislation that is eventually enacted is compromised as the House has to consider all the legislation within a compressed period of time. Consequently, to avoid any further crisis relating to consideration and enactment of legislation required for implementation of the Constitution, the Committee is of the view that the outstanding Bills should be published at the earliest so that Parliament can commence work on the Bills in good time.

## Specific Committee Observations

- (i) The Committee observes that a total 743 Kenyans including 407 men and 336 women have been appointed to serve in Commissions, Independent Offices and the Judiciary since the promulgation of the new Constitution.
- (ii) All the legislation required for appointment of the respective Commissions was passed by the House in time despite the fact that in a number of cases the Executive tabled the Bills very late.
- (iii) The process of enactment of legislation and appointment of some Commissions was fraught with numerous challenges despite Parliament meeting the constitutional deadlines as set out in the Fifth Schedule. Such Commissions include:-
  - a) The Commission on Revenue Allocation (*Act commenced on 30/08/2011 while Commissioners were Gazetted on 30/12/2010*)
  - b) Salaries and Remuneration Commission (*Act Commenced on 29/07/2011 and Commissioners Gazetted on 30<sup>th</sup> December, 2011*)
  - c) The National Police Service Commission (*Act Commenced on 30/08/2011 and Commissioners appointed*)
  - d) The National Land Commission (*not yet appointed despite parliament having vetted and approved nominees*)
- (iv) The House with its wisdom split the Kenya national Human Rights and Equality Commission as proposed in the Constitution into three independent Commissions. The rationale for the split was to ensure effective address to issues of gender and equality, Human rights and administrative of justice. The three Commissions are: -
  - a) The Kenya National Commission on Human Rights,
  - b) The National Gender and Equality Commission, and
  - c) The Commission on Administrative Justice
- (v) The House had to extend the term of two Commissions and a Board namely: - the Truth Justice and Reconciliation Commission, the National Cohesion and Integration Commission and the Judges and Magistrates Vetting Board to enable accomplishment and fulfillment of their mandate.





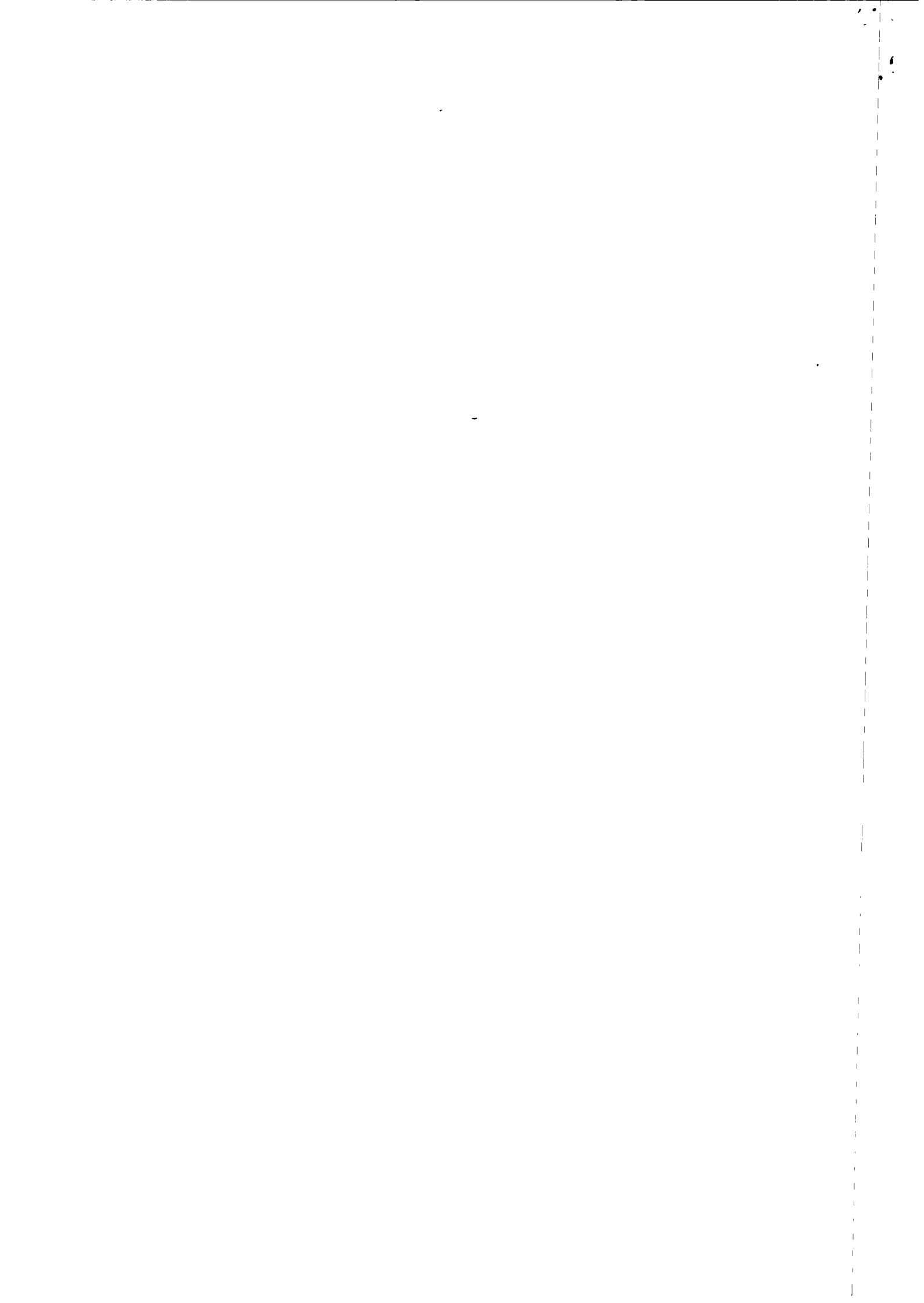
