CHAIRPERSON'S FOREWORD

The State Department for Tourism, invited the Departmental Committee on Sports, Culture and Tourism to attend the International Conservation Caucus Summit and Gala 2018, held between 21st and 28th September in Washington DC United States Of America. The summit brought together Legislative leaders from Africa, Latin America United Stated of America, business and civil society stakeholders, conservation experts and U.S Government and multilateral Organizations met at the historic Mt Vernon, Virginia, home to the late George Washington to discuss the role of Conservation governance in addressing threats and responding to opportunities related to parks and protected areas.

In light of this, the Departmental Committee on Sports, Culture and Tourism nominated a delegation of two Members and one Parliamentary staff to participate in the summit. The International Conservation Caucus Summit was attended by representatives from Kenya, Gabon, Zambia, Mozambique Malawi, Namibia, Botswana Colombia, Peru, Mexico and the United States. Caucus Co Chairs led these delegates.

ICCF President John Grantt gave the opening remarks were he informed the participants the achievement and challenges of ICCF globally through partnership with parliamentary caucuses. Other speakers were David Barron, founder of ICCF, who led the Co- Chairs in Signing the Mt. Vernon declaration.

Conservation experts divided the summit into two sessions where the first session was the presentation of country reports by the Co- Chairs and the second session was presentation from ICCF Conservation stakeholders

The Committee wishes to thank the Offices of the Speaker and the Clerk of the National Assembly for the support extended to the delegation to undertake this important event that offers a deep insight not only in regards to our conservation, but also on the growth of our Tourism industry.

The Committee wishes to record its appreciation for the services rendered by the staff of the National Assembly attached to the Committee. Their efforts made the work of the Committee possible.

On behalf of the delegation and the Departmental Committee on Sports, Culture and Tourism, it is my pleasant duty and privilege to lay on the Table of the House, our report of the participation in the International Conservation Caucus Summit and Gala 2018.

1.0 INTRODUCTION

The Departmental Committee on Sports, Culture and Tourism is one of the fifteen departmental committees of the House established pursuant to Article 124 of the Constitution of Kenya 2010 and Standing Order 216 of the National Assembly and mandated to:

- (a) investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
- (b) Study the programme and policy objectives of ministries and departments and the effectiveness of the implementation.
- (c) study and review all legislation referred to it;
- (d) study, assess and analyse the relative success of the ministries and departments as measured by the results obtained as compared with their stated objectives;
- (e) investigate and inquire into all matters relating to the assigned ministries and departments as they may deem necessary and as may be referred to them by the House;


2.1 BACKGROUND INFORMATION

2.1.1 The ICCF Group

The ICCF group was created to bring together governments, business and NGOs to inspire conservation action and create innovative solutions. ICCF derives to result on range issues including oceans conservation, parks and protected areas management, and wildlife trafficking around the world, the ICCF Group is working effectively to address some of our planet's most pressing conservation challenges.

2.2 Individual Country Reports

This Session was moderated by Rick Lazio, Other Panelists were Nick Lapham, President band Foundation, Kaddu Sebunya, President of AWF, and Sue Lieberman, Vice President, International Policy.



Hon Chachu Francis Chachu Ganya reported on the achievement and challenges of PCC-K since its inception in 2012. Notable achievements were the passage of unprecedented new penalties for wildlife crime in the Wildlife Conservation and Management Act, 2013, ban on Plastics paper bags, passage of the water bill 2014 and demolition of illegal structures along riparian land. PCC-K co-hosted East African Policymakers and leaders in wildlife management, tourism and conservancies to enhance the value of wildlife for communities, businesses and the environment. Hon Chachu did not hesitate to mention the challenges of PCC-K has gone through which are, Human Wildlife Conflict, lack of proper coordination between the investigation and the prosecution units and lack of proper training in the area of statement taking from suspects.



3.0 ICCF 2018 ANNUAL GALA



Magical Kenya was one of the sponsors of this year's annual ICCF gala that was held on the 25th September 2018 at Mellon Auditorium. H.E Mokgweetsi Masisi, President of Botswana, graced the occasion. International Policy makers from Africa and Latin America, United states congress, Permanent Secretary State Department of Wildlife Kenya, Dr Margaret Mwakima, Governor Amason Kingi of Kilifi County, Betty Rodier, Chief Executive Officer Kenya Tourism Board, Betty Ichana, Regional Marketing Manager (USA & CANADA)- Kenya Tourism among other delegates




In her opening Remarks, Dr Mwakima noted that Kenya is one of the world's most bio-diverse country with a global reputation for wildlife conservation and tourism. The country's wildlife is an extremely important economic asset which attracts tourists per year, resulting with a tourism industry that generates over

10% of the national gross development product (GDP) and directly employs about 11% of the total formal workforce.

In her Conclusion she was excited to announce the milestone by Kenya and USA, as Kenya Airways (KQ) in partnership with Delta Air is set to launch its inaugural direct flight from Nairobi to New York City (JFK intl Airport) on 28th October 2018.

3.1 Stakeholder meetings

On 26th September 2018, delegates from African Countries held meetings with multilateral agencies and U.S government agencies at the Headquarters of Global Environment Facility (GEF).





Delegates met with representatives of by USAID, U.S Fish & Wildlife Service and U.S forest services. The purpose of these meetings was to have each country discuss their achievements as well as challenges in the area of Conservation and Natural resources Management that can be supported by proceeds from these agencies

Dr. Margaret Mwakima emphasized on the need to:

- Strengthen the anti-poaching strategy and mechanism in Kenya
- Enhance management of our biodiversity and ecosystem,

- Strengthen and reengineer Kenya Wildlife Services,
- Promote strong coexistence between human and Wildlife
- Incorporate innovation and technology in conservation

3.3 Meeting with Multilateral agencies

The multilateral agencies were represented by representatives from World Bank, GEF, and Wild Foundation. The representative of the World Bank pointed out that a World Wildlife Fund was available and that each country could have access to its funding.

Dr. Mwakima, Hon Chachu and other Kenyan delegates present in the meeting shared a detailed proposal for funding that majored on the implementation of the National Wildlife Strategy 2030. They requested for funding for the following activities

- Need to have a strong rapid response unit to support human wildlife conflict for coexistence. @ \$200M
- Need to create a wildlife rescue Centre to house injured and orphaned wild animals
 @\$150M
- Creation of wildlife conservation museums and national heritage Centre for information and awareness @\$ 200M
- Need to Carry on a campaign dabbed as Kenyans for wildlife and wildlife for Kenyans to mitigate HWC @ \$150M
- Economic valuation of wildlife which requires formation of a wildlife protection fund
- Need for tourism sector to prioritize rehabilitation of parks @ \$150 M

3.4 Meeting at the Capitol Hill



On September 27, 2018, African caucus delegations went to Capitol Hill, at the US Senate, to meet with representatives of the United States Senate and House of Representatives. The Ocean Conservation Caucus initiative was presented to African delegations, by ICCF carol Weiss who informed the delegates that Ocean Caucus priority was to promote and encourage aqua farming. She noted that Marine debris law was an equivalent of the law of plastic ban in Kenya, It was also observed that Gabon had the largest marine protected area at 43%. Notable challenges discussed was the pollution of the ocean by oil from the ships and also illegal fishing.



Delegations also had the opportunity to exchange with the Congresswoman Hon Karen Bass who is a member of the United States house of representatives since 2010,. She is also a member of the Foreign Affairs Committee and Subcommittee on Africa, health and human rights, and a member of the US Congressional International Conservation Caucus. Hon Karen noted that the challenges faced by African countries were similar to those she faces in her constituency. Sat the end of the deliberation, the congresswoman reassured the delegates that she was fully dedicated to Africa.

4.0 OBSERVATIONS

Having attended the event, the delegation observed the following:

- 1. At the close of the 2018 ICCF summit and Gala, all delegates were in agreement that Conservation is an issue that cuts across all spheres of the environment we live inform the Alps in Europe to the Sahara desert in Africa. Globally, we are all bound by nature, which is the fabric that holds our universe together.
- 2. The Co-founder of ICCF David Baron led all the delegates Co Chairs in signing the Mt. Vernon declaration which tasks parliamentarians to work together to advance the goal of conservation sustainable development in adopting laws and policies that promote better use natural resources.

5.0 RECOMMENDATIONS

The delegation recommends the following:

- 1. The caucus to lobby regional blocks like SADC, EAC and ECOWAS not targeting the African Union to come up with regional and continental protocols which may be ratified by member states.
- 2. Involvement of communities as major stakeholders to make them own and embrace the wildlife in their environment. There is need for public participation while coming up with structures within communities to embrace wildlife.
- 3. The Government should embrace modern technology in monitoring and tracking of wildlife to deal with the poaching menace.
- 4. The Government should allocate sufficient budgets for the wildlife sector and to ensure there are strategies and remedies to safeguard human wildlife conflicts within the communities that are normally affected.
- 5. Cross boarder strategy involving all neighbouring counties to deal with the poaching menace.
