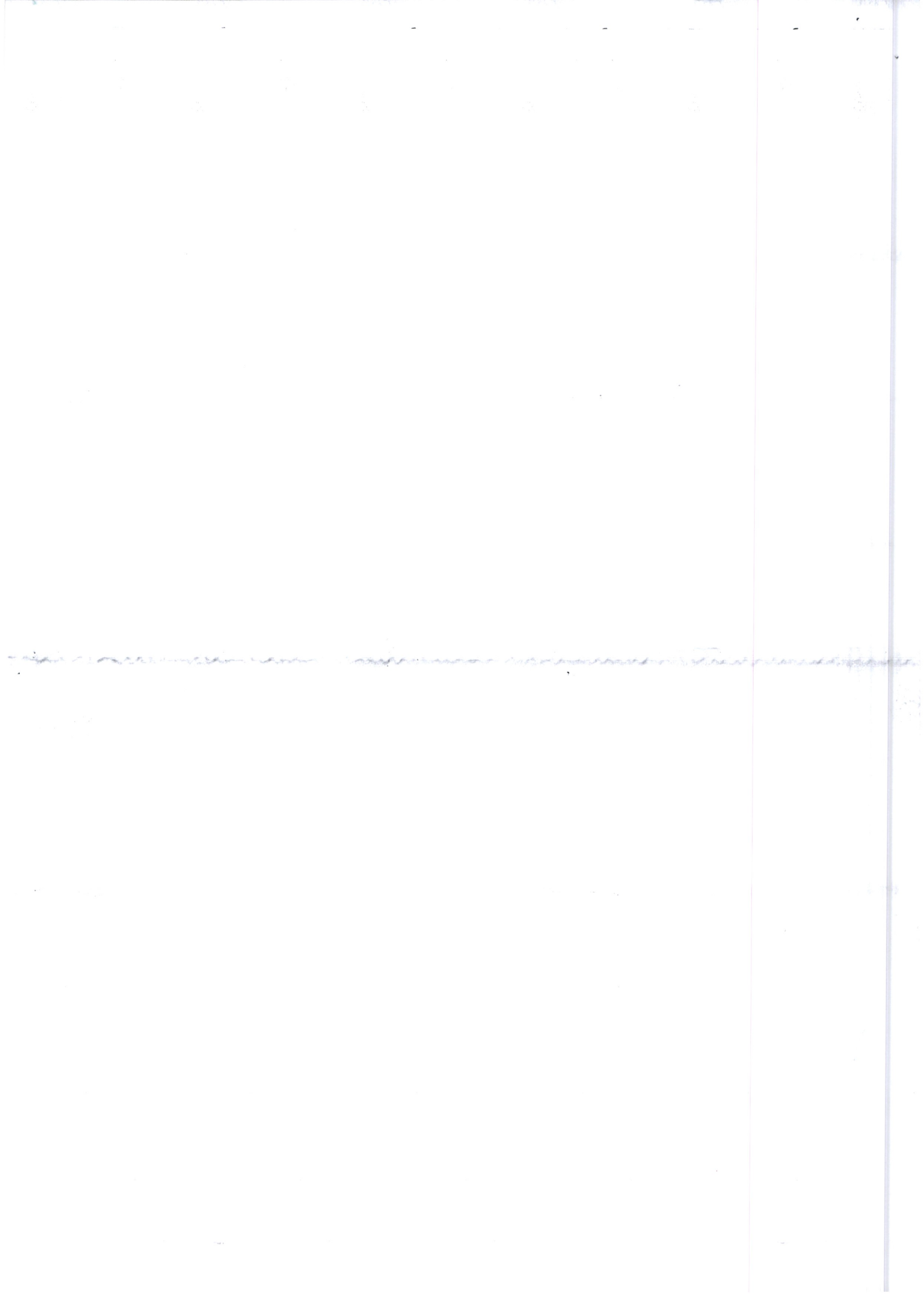

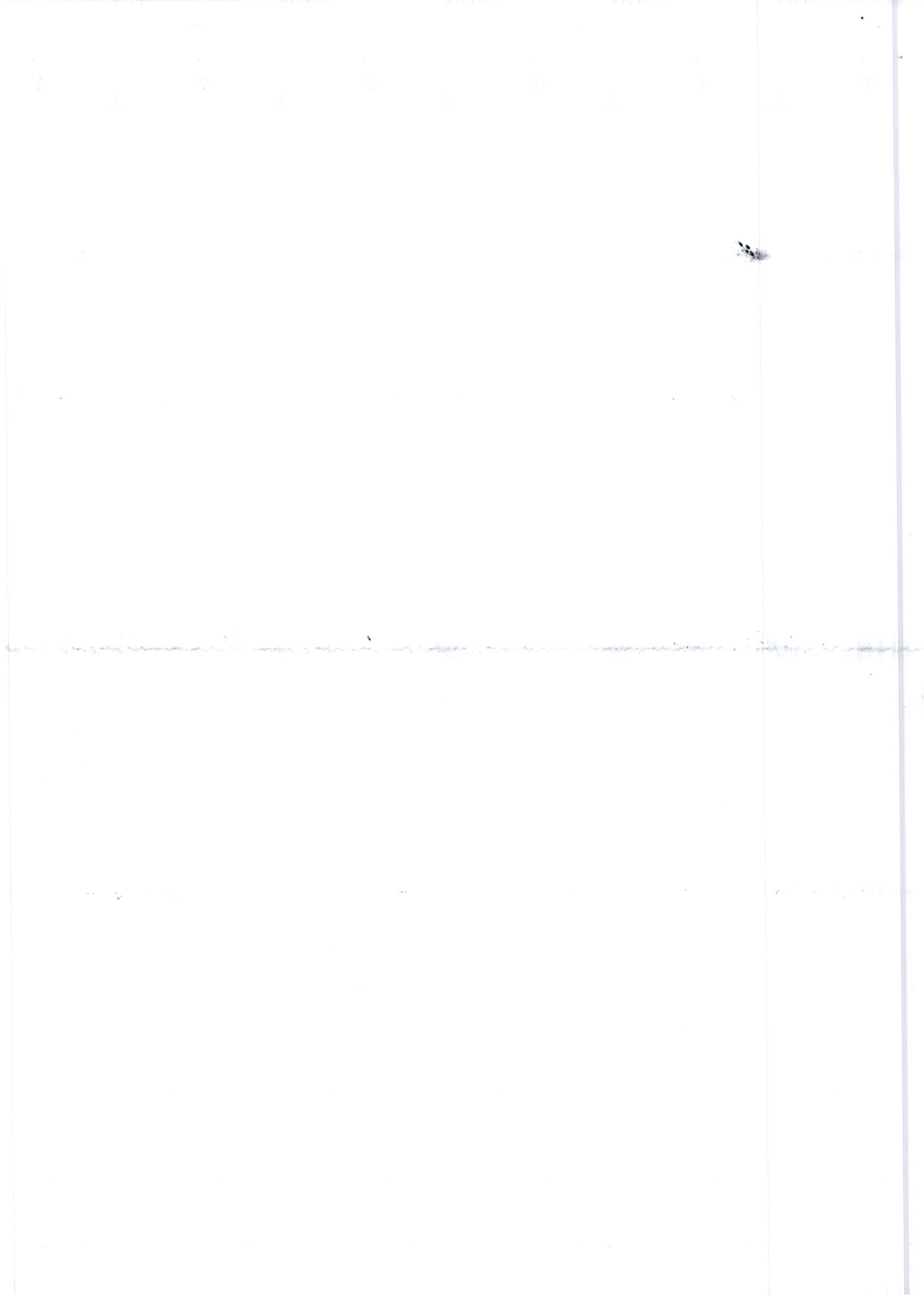


## **CHAIRPERSON'S FOREWORD**

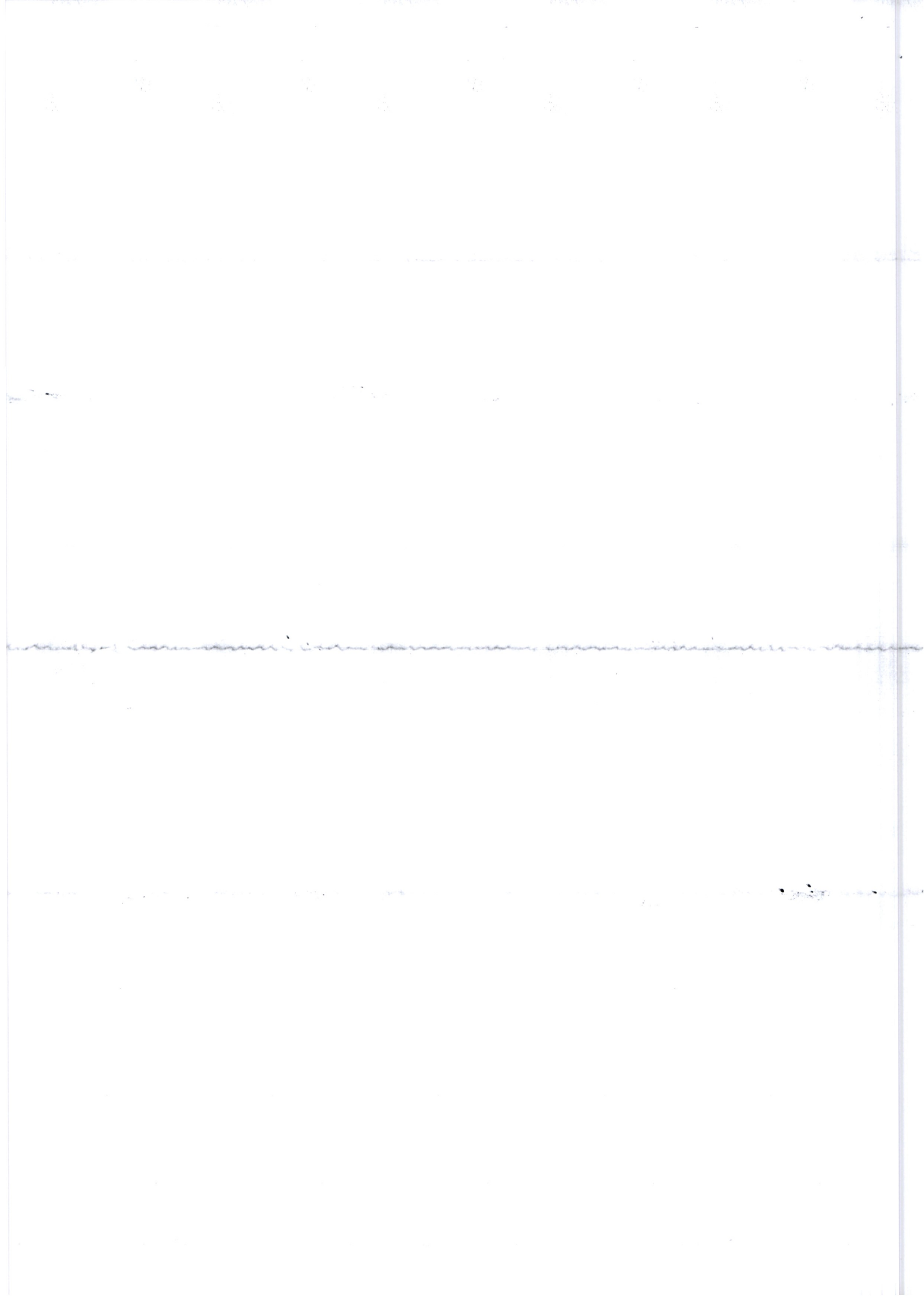

## 1.0 PREFACE

1. Through a letter from the National Construction Authority dated 23<sup>rd</sup> November 2022, the National Assembly's Departmental Committee on Housing, Urban Planning and Public Works was invited to the World of Concrete forum, in Nevada, the United States of America. The National Construction Authority had, in partnership with the U.S. Embassy in Nairobi, organized for the participation of players in the construction industry to the forum, with an aim of drawing lessons and creating connections and synergies among different construction stakeholders.

### 1.1 Committee Mandate

2. The Departmental Committee on Housing, Urban Planning and Public Works is established under Standing Order 216(1) whose mandate, pursuant to the Standing Order 216 (5), is as follows;
  - a. *investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;*

  - h. *(deleted).*
  - i. *consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and*
  - j. *examine any questions raised by Members on a matter within its mandate.*
3. Further, the Second Schedule to the Standing Orders mandates the Committee to consider matters relating to the following subjects:
  - a) Housing;
  - b) Public Works;
  - c) Urban Planning;
  - d) Metropolitan Affairs;
  - e) Housing Development; and
  - f) Built Environment.





4. In executing this mandate, the Committee oversees two State Departments under the Ministry of Lands, Public Works, Housing and Urban Development., namely:
- The State Department of Housing and Urban Development; and
  - The State Department of Public Works.

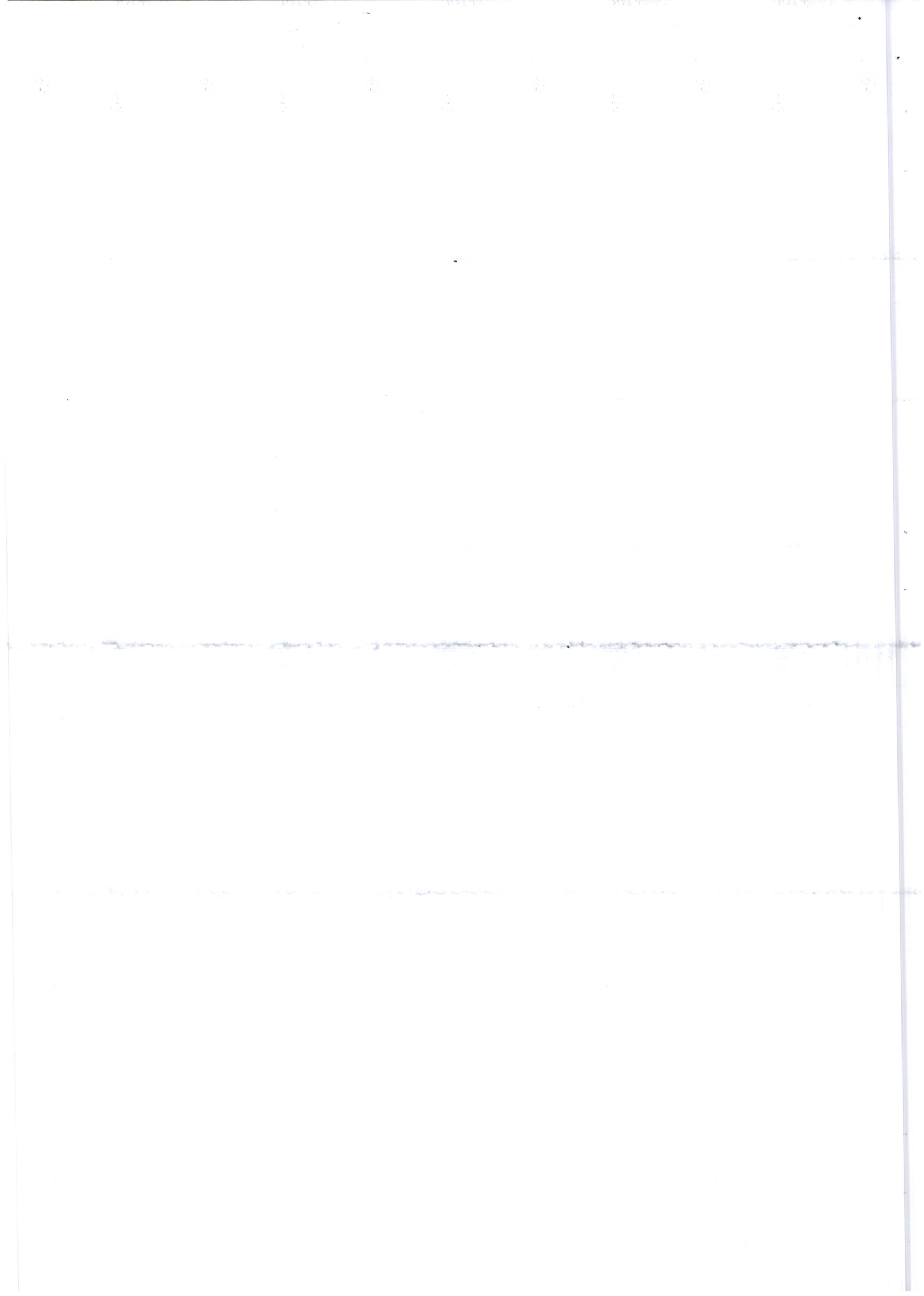

## **2.0 THE NATIONAL ASSEMBLY'S DELEGATION**

7. The National Assembly Delegation comprised of the following:
  - (i) The Hon. Mugambi Murwithania Rindikiri, M.P. - Leader of the Delegation
  - (ii) The Hon. Caleb Mutiso Mule, M.P. - Member of the Delegation
  - (iii) Mr. Ahmed Salim Abdalla - Secretary to the Delegation

The delegation was accompanied by contractors from Kenya, officials from the National Construction Authority and staff from the United States Embassy in Nairobi.

## **3.0 INTRODUCTION**

8. Following an invite from the National Construction Authority dated 23<sup>rd</sup> November 2022, the National Assembly's Departmental Committee on Housing, Urban Planning and Public Works sent representation to the World of Concrete forum, Las Vegas, Nevada, the United States of America. The National Construction Authority had, in partnership with the U.S. Embassy in Nairobi, organized for the participation of players in the construction industry to the forum, with an aim of drawing lessons and creating connections and building synergies among construction stakeholders.
9. The National Assembly delegation consisting of Hon. Mugambi Murwithania Rindikiri and Hon. Caleb Mutiso Mule departed for the United States of America on Friday, 13<sup>th</sup> January 2023 and returned to Nairobi on Sunday, 22<sup>nd</sup> January 2023.
10. The delegation visited a number of exhibitions stands at the forum, and interacted with numerous exhibitors, drawing a considerable wealth of knowledge on matters construction. The forum was held at the Las Vegas Convention Centre.

### **3.1 Visit to the World of Concrete**

11. During the visit, the delegation met with a number of exhibitors, and interacted with various stakeholders in the construction industry.
12. Touted as one of the world's largest trade shows for the commercial concrete and masonry construction industries, the World of Concrete held its 49<sup>th</sup> annual event at the Las Vegas Convention Center (LVCC) in January 2023. With 48,000 registered professionals, heavy show floor foot traffic and more than 120 countries in attendance, the event further solidified itself as the critical meeting place for industry advancement.
13. World of Concrete is an annual international event dedicated to the commercial concrete and masonry construction industries. Featuring indoor and outdoor exhibits with the industry's leading suppliers showcasing innovative products and technologies, exciting demonstrations and competitions, and a world-class education program.





14. World of Concrete's premium education program offered more than 160 technical sessions, including hands-on training, safety expertise and business development.
15. The Concrete Industry Management (CIM) program held its Silent & Live Auctions, generating a record-breaking fund of more than \$2.1 million. Designed to prepare students for the concrete workforce early in their careers, the CIM education program provides students with a Bachelor of Science degree in Concrete Industry Management, a business program specifically developed for the concrete industry. World of Concrete also donated \$15,000 to the CIM Education Program for the second consecutive year.
16. Some of the products and companies that the delegation met with at the forum included SpaceCrete, Tuf-N-Lite, Western Forms, among others.

### SpaceCrete

17. The delegation was received at the SpaceCrete exhibition stand by Mr. Michael Butler who is a civil engineer, and design/build contractor. In the category of concrete construction materials, Mr. Butler demonstrated his personally developed 3D-Admix product for concrete. This method allows concrete to be pumped into place to build walls without forms. Redimix concrete is delivered to the jobsite, then thickeners and accelerators as required are injected and intermixed in the pumping line, to give the fluid concrete the zero-slump-with-workability properties.
18. Mr. Butler explained that he had applied for patents in the United States and Europe for his 3D-Admix, an organic additive that noticeably modifies concrete. When the 3D-Admix is injected into the pumping line, the concrete slurry becomes an easily shapeable material that radically improves the process of creating vertical walls that can repeatedly be quickly vibrated down as fast as you can pump it.
19. The delegation was informed that to date, the most common process of creating vertical concrete walls requires the time and expense of building the forms the concrete will be poured into. Large infrastructure projects applied the concrete via the shotcrete method, the process of shooting concrete at high pressure and volume onto a form. However, it requires skilled labor and is now noted for its extreme health hazards due to workers' exposure to silica dust. 3D printing of concrete walls has taken hold, but concrete is a heavy fluid. Getting it to conform to the desired shape requires an expensive, specialized mortar. SpaceCrete product eliminates the need for the high concentration of cement needed for 3D printing or the use of fine powder mortars.
20. Since forming is the biggest cost in concrete construction, Mr. Butler explained that the use of his product for 3D printing means no more forms, thinner walls, less concrete, use of normal rebar, and faster slip forming. He sees 3D-Admix as ideal for basement construction, elevator shafts, wind turbine towers, and even disaster-resistant housing. The mixture not only provides an ideal concentration for 3D printing but also has a few other attributes.





## **Tuf-N-Lite**

21. The delegation was received by the TUF-N-LITE official, Ms. Jenna Doty. The delegation was informed that TUF-N-LITE is an innovative concrete forming and reinforcing manufacturer based out of Monroe, Ohio. TUF-N-LITE began by manufacturing aluminum forms for the residential market but has since picked up other product lines that will have a large impact on the construction market.
22. The company has a number of products including the following:
  - a) MST-BAR: A full line of composite glass fiber rebar products and services for all concrete applications.
  - b) MSB Form: A reusable bracing system to replace the conventional wooden kicker.
  - c) TILT WALL HEADQUARTERS: Offers a full line of concrete tiltwall forming and lifting products and services.
  - d) UF-N-LITE: Offers a full line of aluminum forms, hardware and ties that are all manufactured in the USA.
23. The company prides itself as manufacturers and representatives of industry changing concrete forming and reinforcing products and services. The delegation was of the view that it was ideal as a country if we considered such building technologies while developing the mass affordable housing units.

## **Western Forms**

24. The delegation was received at the Western Forms exhibition stand by the company officials, Mr. Israel Valdez and Mr. Ron Ward. The owner, Mr. Ron Ward submitted that the Western Forms was the original form company, with the largest share base and customer base. He stated that they have been doing business for the last 40 years and have had the honour to engage with a wide clientele including from Nigeria, Ghana, Saudi Arabia, and Iraq among others.
25. Western Forms manufactures aluminum concrete forms for cast-in-place concrete walls. Western forms are used in over 55 countries for building concrete foundations, concrete housing (low to high rise structures), commercial concrete projects, and a wide variety of precast concrete applications.
26. According to Mr. Ron Ward, the Western form aluminum concrete wall forms are faster, lighter, and last longer than other comparative forming systems. The delegation was of the view that West forms is one of the products that Kenya may consider in realizing one of its flagship projects of affordable housing.

## **3.2 Visit to GigaCrete Inc**

27. The delegation was received at the GigaCrete Inc by the company officials on 16<sup>th</sup> January 2023. The delegation was informed that GigaCrete manufactures some of the most abuse resistant, water resistant and high impact coatings as well as high speed home building systems on the market. It was submitted that the products are cost-competitive, 'green' and





capturing the attention of world markets anxious to leave behind old and inferior ways to build.

28. Noting that the delegation's interests were majorly on matters housing, the delegation was informed of a product called GigaHouse. GigaHouse is a super insulated steel framed building system (steel is the most recycled material on earth) utilizing GigaPanel components and it is so energy efficient that a GigaHouse will exceed ICF construction in thermal qualities.
29. GigaHouse super insulated steel-framed construction system specifically targets projects where rapid speed of construction and ease of assembly is important. By significantly reducing labor costs and project cycle times, GigaHouse building system allows a high-performance sustainable structure to be constructed at or below wood framed prices. This is a revolutionary step change in the way we build by reducing onsite labor costs. All walls are super insulated with higher R values starting at R-24 up to R-60. In addition, GigaCrete panels are coated with PlasterMax abuse and fire-resistant interior coatings and waterproof weather resistant StuccoMax exterior coatings and painted any color.
30. The delegation was informed that building operating costs are reduced, HVAC systems can be sized down as much as 60%, and operating times to heat or cool the structure are shortened. GigaHouse provides the thermal efficiency and speed to get any project completed and occupied quickly.

31. At the end of the meeting, the delegation was given the following as highlights of the product:
  - a. Meets IBC steel-framed construction standards, utilizing ICC approved steel studs and EPS foam
  - b. Engineered to withstand hurricane force winds and CA seismic zone 4
  - c. Easily and rapidly assembled by unskilled labor
  - d. Utilizes PlasterMax fire rated interior abuse resistant finishes
  - e. StuccoMax non-combustible waterproof exterior finishes
  - f. No Portland cement = Low Carbon footprint



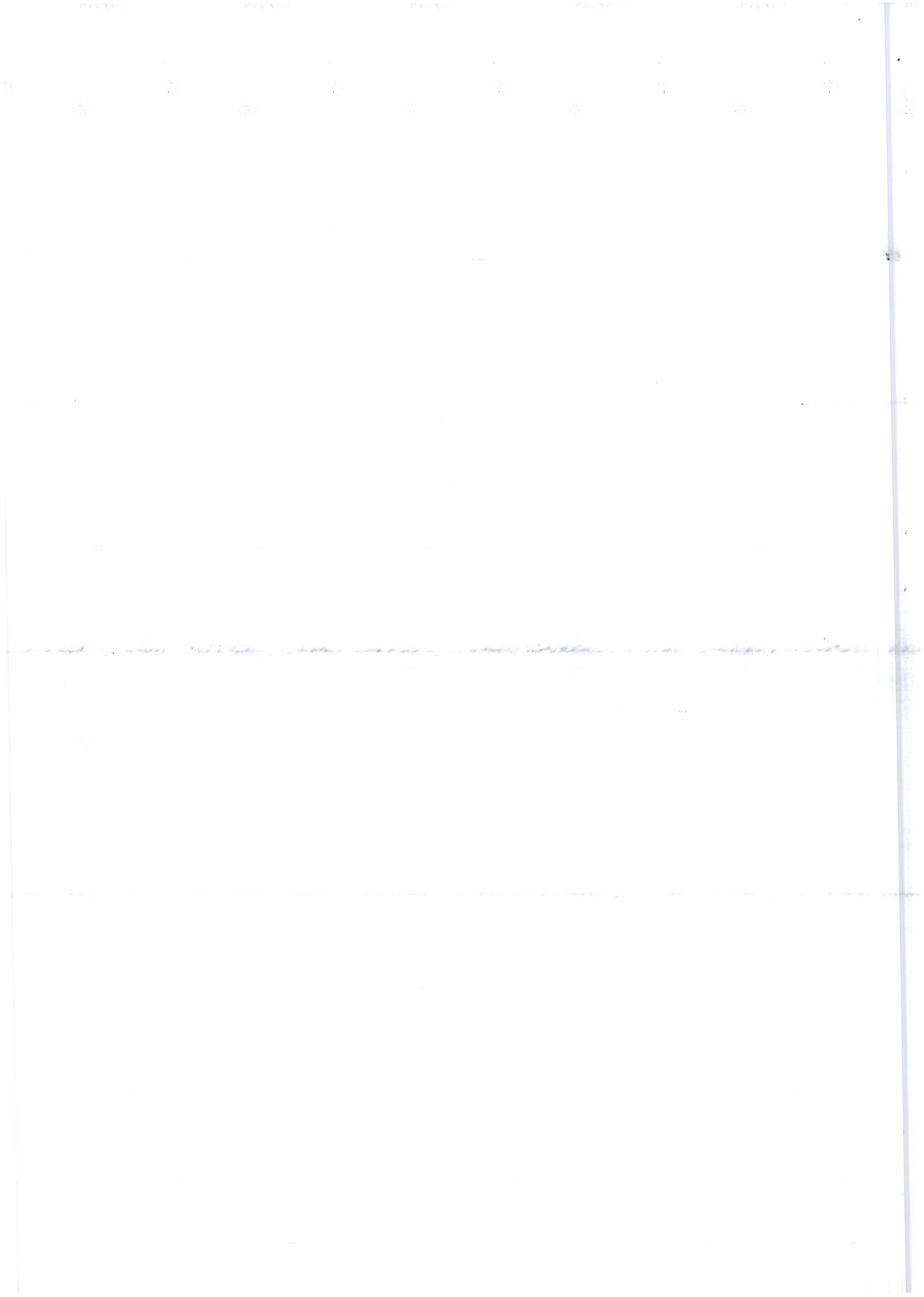


- g. Unlimited design possibilities including curved walls
- h. Ideally suited for Low cost and affordable housing
- i. No wood, No rot, No mold or mildew, insect and fire resistant
- j. Containerized and shipped globally to remote locations as a complete kit
- k. Emergency and Disaster relief permanent housing and shelters
- l. International joint venture factory opportunities are available
- m. Supplier of remote location housing for Oil and Gas and Mining industries
- n. Government suppliers of mass affordable housing
- o. Unlimited design capabilities
- p. Lightweight components are hand carried onsite, no need for cranes.

32. The delegation noted that as a country, it was important to consider products such as GigaHouse to realize the faster achievement of the affordable housing agenda.

### 3.3 Visit to Substrata

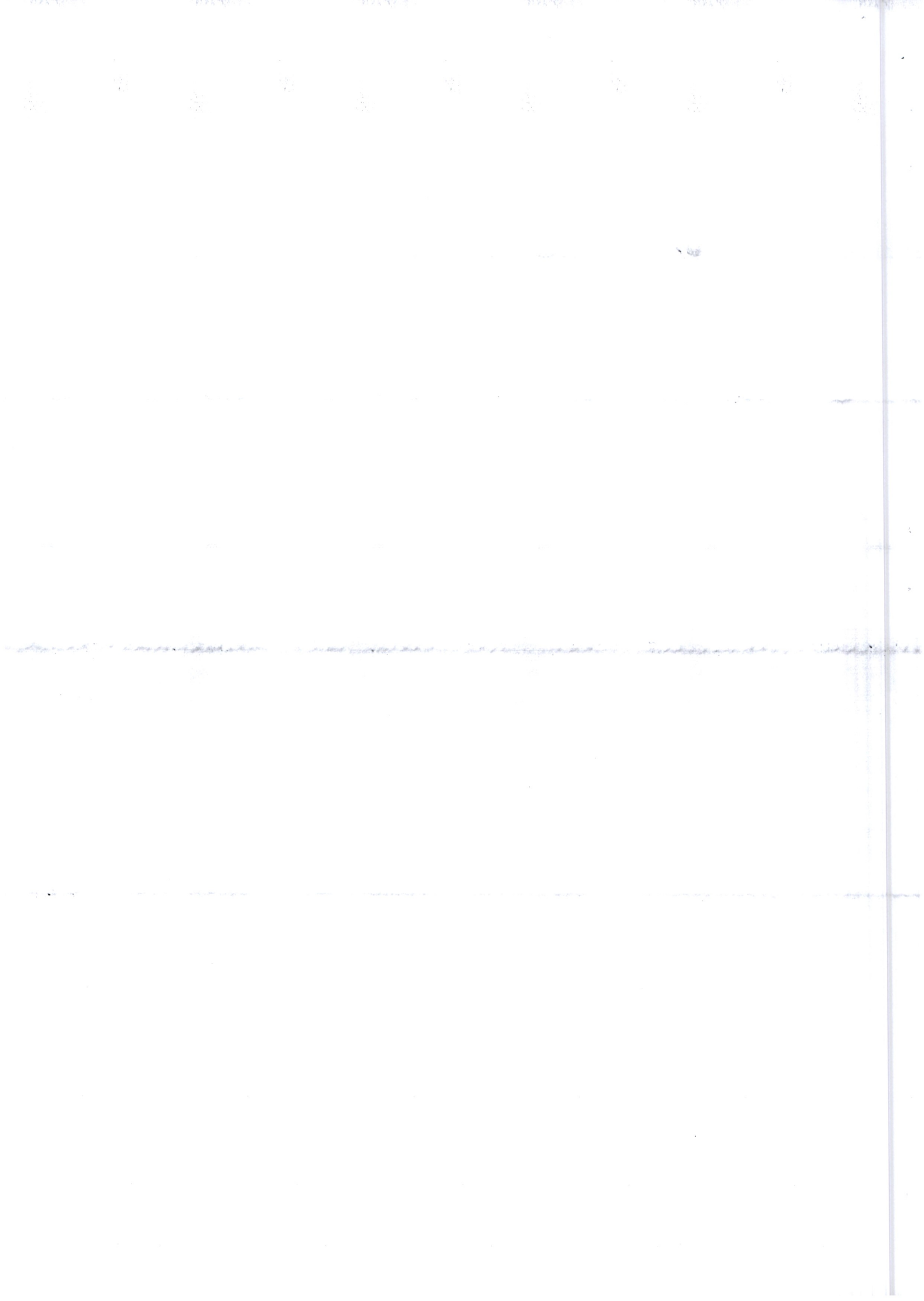
33. The delegation visited a company called Substrata on 18<sup>th</sup> January 2023. The delegation was accompanied by officials from the National Construction Authority, and Kenyan contractors including Mr. Aggrey Maganga, Mr. Henry Mugo Berenje and Mr. Simon Kimani Waithima. At the Substrata offices, the delegation was received by the company officials including Ms. Kat Zahnow and Mr. Mario Rivera.
34. The delegation was informed that Substrata has been solving the biggest challenges in soil stabilization, soil conditioning, cleaning, odor control, and petroleum-based bioremediation for over 40 years. The company's family of enzyme-based soil treatment has expanded into four flagship products known as Perma-Zyme, Petra-Zyme, Bacto-Zyme, and Harva-Zyme. The delegation was however particularly interested in Perma-Zyme because it was the product that had the potential of improving roads infrastructure at affordable and quicker ways.
35. The delegation was informed that Perma-Zyme can be used in both paved and unpaved roads to create a concrete-like surface. This is used as a cheaper substitute to tarmac roads and a better alternative to the ordinary murrum roads. The road surface is said to be so strong such that even when hit with a hard object such as a hammer, the impact is very minimal. The product once mixed with the soil can increase the soil strength by upto 13 times.



36. Requirements for using the Perma-Zyme product are relatively easy. For instance, the native soil must contain at least 20% clay and that no rain during the 3-day curing period. However, in the event of rain, there are cures. Further, the local temperature should be above 4 degrees Celsius. Water normally acts as transportation mechanism for the product to fully penetrate the soil. Compaction thereafter pushes the clay particles close together, allowing the product to generate a strong bond between soil particles, resulting in a concrete-like surface. It was reported that the Perma-Zyme continues bonding the clay together for upto 10 years.



37. The delegation noted that the product was safe to apply since it may not harm the machinery and occasions no health risks to workers. It was also reported that it was environmentally friendly because it cannot leach into the water table and it cannot harm wildlife.





**4.0 COMMITTEE’S OBSERVATIONS**


38. The Committee delegation observed as follows:

- i. There are numerous technologies in the construction industry, some of which are proven, affordable and sustainable. For instance, the delegation was convinced that GigaCrete's high quality homes and buildings were affordable because they are built with speed, are energy-efficient, and require minimal maintenance.
- ii. There was need to adopt a more flexible approach in construction if the government was to make faster progress in affordable housing projects. This includes making utmost use of new building technologies, some of which are cheaper.

**5.0 COMMITTEE’S RECOMMENDATIONS**

39. The Committee recommends that the National Construction Authority prepares a data bank of all the relevant new-build technologies and develop mechanisms for their identification, standardization and recognition.

40. With an increased interest in the use of fiber-reinforced concrete in concrete pavement applications in the construction industry, the Committee recommends that the National Construction Authority develops clear and detailed guidelines and recommendations on how to properly select and use fiber in concrete.

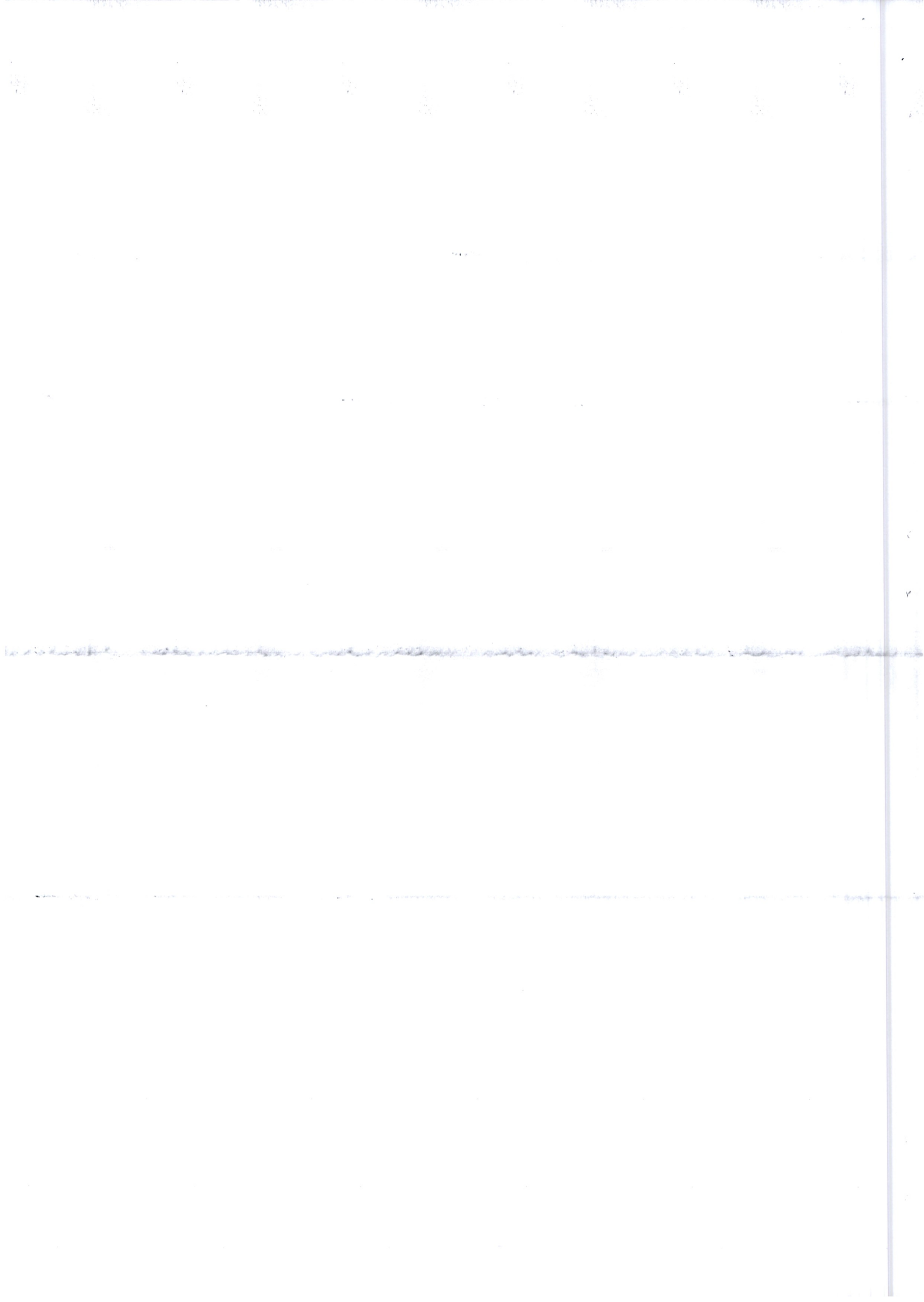

**MIN No. HUPPW 093/2023:**                    **CONSIDERATION OF THE NATIONAL CONSTRUCTION AUTHORITY (AMENDMENT) BILL, 2022**

The Committee indicated that since the proposed amendments were touching on a special group of the society i.e. the youths, women and those living with disabilities, they needed more time to thoroughly scrutinize the changes proposed and their long-term effects both to the Construction Industry in general and the revenue streams of the National Construction Authority, NCA.
